The Lessor agrees to lease, in good working order, to Lessee who accepts, a vehicle and its accessories (the Equipment) at the times and in consideration of the rental cost, all as described herein, and subject to the following conditions.

- The lease of equipment is limited to the lease period described herein.
- Before and after each use period, the Lessee shall inspect the Equipment with the representative of the Lessor**
- Before using the equipment, the lessee will receive a security briefing related to the activity and the use of a snowmobile.**
- The Lessee will strictly observe the instructions of the Tyroparc representative. Failing this, the representative may immediately terminate the activity, Additional fees may be charged for any late returns.
- Late fees for unguided rental tours :** If you are not back at the allotted time, late fees will be billed at the rate of \$35 + taxes for each 30 minutes for the first hour and of \$100 + taxes per hour for every following hour.
The lessor declares to have read the requirements for late fees.

- This contract constitutes the entire agreement between Lessor and Lessee; any derogation shall be made by writing.
- This lease agreement is governed by and shall be construed in accordance with the laws of the province where the Lessor is established.
- During each use period, the Lessee shall use the Equipment:
 - Having his driver's license, valid and in force, in his possession;**
 - Respect all applicable laws, employ safe driving habits and in a reasonable manner;
 - Driving only where authorized;
 - Using the safety accessories mentioned in the prescribed way;
 - Never following too close to another vehicle;
 - At no time, allowing any other person to drive or make use of the vehicle;**
- At the end of each lease period, the Lessee shall reimburse the cost of repair of any damages to the equipment arising by accident, improper use, fire, theft, or any other cause. **The Lessee agrees to notify the lessor of any incident occurring during the rental period.**
- The Lessee is solely responsible for any consequence, fine or penalty arising because of this failure to follow the law applying to the use of the equipment**
- The Lessor reserves the right, in its discretion, to cancel equipment use for any use period, if reasons of security, climate, temperature or convenience requires it.
- The Lessee is solely responsible. To the absolute exclusion of the Lessor;
 - for any damage or loss whatever arising from use of the equipment;
 - for the security of its goods, his person as well as those of any third party who participates in the use of the equipment.**
- The Lessee has no right to any credit or reimbursement of the lease cost of the equipment in case of non-use or failure to use during any use period regardless of the reason.
- This rental contract is a personal agreement between the parties. The Lessee does not have the right to assign or sublease to a third party without the prior written consent of the Lessor.
- The waiver of any right in the case of a default hereunder does not constitute a waiver of such right in the case of a prior or subsequent default.
- In the case of any legal proceeding, the parties elect the jurisdiction of the civil courts of the Lessor's district.
- THE LESSEE ACKNOWLEDGES: that this contract is duly completed, bears the signature of the Lessor and that a sufficient delay was given to him to read and understand the nature, terms and conditions of this contract before he signs his name.
- A security deposit will be taken for each rental of a snowmobile** from the Lessee in case there is damage to the equipment. The Lessor will refund the deposit at the end of the term of use of the activity, if no damage is caused to the equipment.
Refusal or the inability to pay the deposit by the client automatically entails the cancellation of the tour. No refund will be apply.
